- A. Cost to install an interior access panel and a cut-off valve at the four buildings. \$4,620
- B. Isolate individual line runs and determine which run(s) are leaking. We would do this on an hourly rate of \$92.60/hr
- C. At the site run(s) of pipe that are determined to be bad, cost per lineal foot to replace the bad piping with pipe as described above. \$50/ft; if underground add \$2,600 digging cost per underground location
 - D. Test newly-installed line and each of the existing lines to 150 PSI for two (2) hours. \$185.20

It is our understanding you have been contacted about submitting a proposal for gas line work at our facilities. There follows the anticipated scope of work, and attached is a rough sketch of our campus and gas line information known and/or available to us.

Anticipated Scope of Work:

- 1. Install an isolation valve at the gas line entry into each of the four buildings (Office, Nursery, Fellowship Hall, and Baker Building).
- 2. Where the gas line enters each building, install an interior vented access panel (could be as simple as an HVAC sidewall diffuser).
 - 3. Isolate the buildings to determine which line is leaking.
 - 4. At the bad line, replace the underground line with fused HDPE pipe.
 - 5. Five feet (5') before the building, transition from HDPE pipe to standard steel gas

pipe with treaded fittings. Extend the standard stell gas pipe to the newly-installed cut-off valve at the building.

- 6. Please provide the following pricing:
 - A. Cost to install an interior access panel and a cut-off valve at the four buildings.
 - B. Isolate individual line runs and determine which run(s) are leaking.
- C. At the site run(s) of pipe that are determined to be bad, cost per lineal foot to replace the bad piping with pipe as described above.
- D. Test newly-installed line and each of the existing lines to 150 PSI for two (2) hours.
- 7. Please provide (a) approximate time from a Notice to Proceed to when work may begin; and (b) approximate duration of the work (understanding that the scope hasn't yet been defined).
- 8. If possible, please submit your estimate of cost via email by **noon, Friday, July 16.** This issue will have to go before our Financial Committee the week of July 19.




